### **IMPORTANT INFORMATION – NEW MEMBERS**

- 1) You must be 19 years old at time of application
- 2) You must complete and submit a Criminal Record Check (CRC) to be renewed every 5 years.

**Instructions:** Go to the RCMP Detachment to complete the CRC form. Bring two pieces of Government ID, of which one must be a photo ID. There is no cost for this check.

**Note:** If the CRC indicates a result other than “negative” in Part 2 of the form, the YKSAR Board of Directors will review the record and advise you of your application status. *Your membership fee will be refunded if your application is rejected.*

- 3) Mail both completed forms to the address as listed above along with your membership fee. Cheques can be made payable to “**Yellowknife Search and Rescue**”.

## **GENERAL MEMBERSHIP FEES - INFORMATION**

1. YKSAR memberships fees are paid annually commencing 1 April to 31 March. There is no pro-rating of fees.
2. YKSAR has reciprocal agreements with other recreational groups / associations as indicated below. You may ask to be exempt your fee, if you have a valid membership with one of the following groups:

Great Slave Snowmobile Association; Yellowknife Climbing Club; or, Somb'ke Paddling Club (partial exemption - must pay discounted fee of \$15)
3. To claim the exemption, your current membership status must be verified by email or letter from the President of the partnering group you belong to and attach it with this application form.

**If member fees are not paid by July 1 of the current year** - the fee will be considered overdue. Overdue Members will no longer be notified of training sessions or items of interest to members and will not be considered as an immediately available resource. They remain on the membership list as an inactive resource who can be called upon in extreme requirements.

**Fees in arrears** – members who have **not paid within 30 days of the end of the fiscal year** must pay both the fees in arrears and the current fee to be reinstated.

Members who have **not paid within 90 days of the end of the fiscal year** (i.e., 1Year plus 3 Months) will be removed from the membership list for non payment of fees. Members may re-apply to join YKSAR as a new member, subject to all the requirements of a new membership.
